**OLD BUSINESS: (1-2)** 

#### 1. Tulare Street Update

At the May meeting, the Commission had discussion on the need for an improvement project on Tulare Street, specifically to the parkway, sidewalk and walkway fencing. This property is owned and secured by BNSF Railroad.

Streets Superintendent, Jeff Porter reported that Operations Manager Gerry Lopez is working with the Director of Public Works and the engineering department on a Capital Improvement Project (CIP) proposal. There is no update at this time.

## 2. Neighborhood Improvement Project

The Commission discussed the upcoming Neighborhood Improvement Project (NIP). This year the BE Commission will assist in painting house address curb numbers and planting trees on Saturday, September 30, 2017.

Jeff Porter reported that Public Works staff will paint fire hydrants and sweep the designated track of trash and bulky furniture items before the Commission meets on Saturday, September 30, 2017.

At the August meeting, the Commission will receive door hangers and more information on the housing track designated for this year's NIP.

## **NEW BUSINESS: (1)**

## 1. Architectural Awards Program

In an effort to encourage property owners to take pride in maintaining well-kept buildings and grounds, the Beautification-Environmental Commission hosts the annual Architectural Awards Contest. Residents, members from the business community, Commissioner's and City staff are encouraged to submit nominations for properties that display beautifully landscaped lawns and buildings with unique features that enhance the neighborhood where they reside.

Award criteria include building features that make the structure aesthetically pleasing, unique special details and energy efficient features such as drought tolerant plants and landscaping. The process consists of a community notification of the program, a nominations period, and a Saturday when the Commissioner's judge the nominations. Winners are then notified and informed they will be recognized at a City Council meeting.

Staff is requesting that Commissioners approve that the awards nomination period begin on Monday, July 31, 2017, with a deadline of Monday, August 21, 2017. The bus tour judging will be held on Saturday, September 9, 2017; awards to be presented at the City Council meeting on Tuesday, September 26, 2017.
