DISCUSSION:

Super Senior Saturday is the largest special event for the Senior Activity Center. This year's theme is "Are You Prepared?". This event will give tools for seniors to be prepared for retirement, health issues and emergencies. In anticipation for this event staff is requesting a total of \$2,000 from the Interior Development Account or IDF (11-2248). The funds are used for supplies, decorations and other related expenses. The current balance of the IDF account is \$32,443. Last year this event had 584 participants, 85 vendors and yielded \$4,950 to the IDF account.
