May 28, 2015

CALL TO ORDER: Chair Reynolds called the Senior Citizens Commission meeting to order at 9:00 a.m., City Council Chambers, 6650 Beach Boulevard, Buena Park, California.

- a. New Employee at Senior Activity Center - Maura Ferguson - Margaret Riley, Director of Community Services welcomed new Senior Commissioner, Maura Ferguson.
- b. Veterans Banner Reimbursement – Mark Saucedo, Community Services Supervisor announced \$2,281.24 has been reimbursed to the Interior Development Fund. The banners are currently on display through Memorial Day.
- c. AARP Tax Aide Program & Evaluation Report - Mr. Saucedo reported on the success of the event. This informative event travels throughout Orange County presenting new ideas for Seniors. Staff looks forward to next year's event.


